
### ABOUT BELLARINE CATCHMENT NETWORK

### PRESIDENTS REPORT



2022 has been a pivotal year in Bellarine Catchment Network's 25-year history of engaging with the community to conserve and enhance our local environment. With invaluable input from our members, and under the guidance of staff and a local consultant, BCN developed a Strategic Plan (a little overdue, with the last concluding in 2014!) that clearly defines agreed objectives to tangibly assist our community achieve their environmental aspirations over the next five years. The plan is one of the most significant achievements of the year, but more about that later...

Of course, while the Strategic Plan was under development the work of BCN did not stop. With grateful funding from valued partners the City of Greater Geelong, Corangamite CMA, Borough of Queenscliffe, DELWP, Bellarine Bayside CoM, as well as Landcare and Coastcare grants, our dedicated team, under the leadership of our Program Manager, Matt Crawley, and in collaboration with our members, partners and community, continued delivering comprehensive and effective programs and services, as well establishing new projects focusing on conserving our exceptional environmental assets.

Led by Biodiversity Program Leader, Lachie Forbes, and in partnership with the Geelong Cemeteries Trust, Moremac, CFA, VicTrack and Corangamite CMA, we continued our successful bush regeneration projects across the Bellarine.

Our resources for members were significantly boosted by two key projects in 2022, the first being a Coastal Education Trailer. The trailer, which has been funded from the DAL grants program, is designed to include interactive and interchangeable materials that can be used by member groups to promote their own organisation, and the local environment.

The second resource project developed by Rebecca St Ledger, Coastal Program, Sustainability & Circular Economy Coordinator, was the Bellarine and Geelong Environmental Volunteering Calendar. This online calendar provides our members with a central website to share knowledge, volunteering opportunities, group information and events. The site is designed to be easily found and will encourage environmentally focused people to join our members activities.

BCN continues to partner with our members and community on local projects, as exemplified by the Bellarine Landcare Group and BCN's joint support of the Blue Carbon Lab's studies of Swan Bay's saltmarsh. A project that works collaboratively with private landholders, keen to learn about the incredible capacity of saltmarshes to store carbon. We also furthered our engagement with local business organisations. Environmental education days were conducted for the staff and members of GMHBA and Cultura.

As noted earlier, one of our most significant achievements was the reflective and consultative development of the BCN 2023 – 2028 Strategic Plan. The plan was led, shaped, and adopted under the guidance of Naomi Wells, Communications and Community Engagement Coordinator, and it reconfirms our commitment to supporting and engaging with our members and diverse community in reliable, meaningful and collaborative ways. It also recognises our members as mentors, guides and beneficiaries of our programs and services.

### PRESIDENTS REPORT

This strategic plan commits us to continue to engage and respectfully learn from the Wadawurrung people, Traditional Owners and custodians of the Bellarine, and with their permission, to incorporate their deep and ongoing knowledge and practice of caring for the Bellarine environment, in all our programs and services.

It is a strategy that strengthens our commitment to providing innovative, inclusive, culturally sensitive educational services and resources and effective bush regeneration and maintenance outcomes. A plan that embeds climate change mitigation and circular economy education in all our programs, and acknowledges our responsibility to our staff's wellbeing, and our organisational governance.

The plan also promotes the development of an 'Environmental Education and Community Centre'; a concept that has considerable community support. This opportunity to work collaboratively with our member organisations, the Wadawurrung Traditional Owners and Barwon Water (as the owner of the Bellarine Basin reserve) to create a community run centre that has the potential to be a cultural heritage and environment learning centre is an exciting one. A base for scientific investigation. A central forum for land managers and member organisations, and a hub and meeting space for all the Bellarine and Geelong communities. We look forward to pursuing this project over the next few years.

One of our challenges this year has been the reduction in grant funding to the sector, due to a range of factors governed by Commonwealth and State Government fiscal constraints. In recent years, BCN has been transitioning its financing model from one predominately based on grants, to one based on partnerships. 2022 has seen a further move in this direction, and whilst BCN has recorded a net loss for the financial year, prudent budgetary management has ensured that we have funds to meet our operational commitments.

I want to thank and recognise our dedicated committee, Beth, our Vice President, Margot, our Secretary, Michael, our Treasurer, and committee members, Geoffrey and Bernie, for their much-valued commitment and insightful contributions and governance of our organisation. I would also like to acknowledge and thank our dedicated team, Naomi, Bec, and Bellarine Landcare Group's Landcare Coordinator, Sophie, for their genuine conviction in the importance of, and their unwavering contribution to, the conservation of our local environment. Their energy and commitment to supporting our members and community in creative and practical ways has exemplified our vision and mission.

I want to take this opportunity to also thank Lachie, our Biodiversity Program Leader who has recently resigned to establish his own business providing ecological restoration services to the greater Geelong area. Lachie has been an invaluable member of our team for the last 4 years, actively leading and contributing to our on-ground biodiversity projects, promoting, and educating our community in the intrinsic values of our environment. Lachie has been an esteemed member of our team and we are very grateful for all his innumerable contributions. I particularly want to thank Matt Crawley, our Program Manager. Matt's enduring commitment and engagement with our unique environment has been remarkable and significant. His judicious and innovative contributions, exemplary leadership and support for the team, committee, partners, and membership is the driving force behind our organisation.

Finally, I want to thank our members, partners and community for their ongoing support, perceptive and significant contributions, and engagement with BCN. We are looking forward to continuing our engagement, working cooperatively with you in developing resources and solutions to assist you, and together, conserving and improving environmental conditions for our biodiversity to thrive.

## AUDIT REPORT

#### INDEPENDENT AUDIT REPORT

#### TO THE MEMBERS OF BELLARINE CATCHMENT NETWORK INCORPORATED

#### Scope

#### The Financial Report and Committee's Responsibility

I have audited the attached special purpose financial report of the Bellarine Catchment Network Incorporated, being the Proft & Loss Statement and Balance Sheet for the 12 months period ending 30 June 2022.

The Committee of the incorporated entity is responsible for the preparation and true and fair presentation of the financial report in accordance with Australian Accounting Standards (including the Australian Accounting Interpretations) and the *Associations Incorporation Reform Act 2012* and is appropriate to meet the needs of the members. This includes responsibility for the maintenance of adequate accounting records and internal controls that are designed to prevent and detect fraud and error.

The financial report has been prepared for distribution to members for the purpose of fulfilling the Committee's financial reporting requirements. #### **Audit Approach**

I have conducted an independent audit in order to express an opinion to the members of the entity on its preparation and presentation. My audit was conducted in accordance with Australian Auditing Standards, in order to provide reasonable as to whether the financial report is free of material misstatement. The nature of the audit is influenced by factors such as the use of professional judgement, selective testing, and inherent limitations of internal control, and the availability of persuasive rather than conclusive evidence. Therefore, an audit cannot guarantee that all material misstatements have been detected.

I performed procedures to assess whether in all material respects the financial report presents fairly, including compliance with Accounting Standards and other mandatory financial reporting requirements in Australia, a view which is consistent with my understanding of the entity's financial position, and of its performance as represented by the result of its operations.

I formed an audit opinion on the basis of these procedures, which included examining, on a test basis, information to provide evidence supporting the amounts and disclosures in the financial report.

While I considered the effectiveness of management's internal controls over financial reporting when determining the nature and extent of my procedures, my audit was not designed to provide assurance on internal controls.

#### Independence

In conducting my audit, I followed applicable independence requirements of Australian professional ethical pronouncements.

#### **Audit Opinion**

In my opinion, subject to the effects of such adjustments, if any, as might have been determined to be necessary had the limitation discussed in the qualification paragraphs not existed, the financial report is in accordance with the *Associations Incorporation Reform Act 2012* and gives a true and fair view of the financial position of the Bellarine Catchment Network Incorporated as at the 30 June 2022 and the results of its operations for the 12 months then ended and complies with the Australian Accounting Standards (including the Australian Accounting Interpretations).


