# BELLARINE CATCHMENT NETWORK

Bellarine Catchment Network (BCN) is a non-government organisation and registered charity that is governed by a volunteer committee of management.

The network is made up representatives from 45 key catchment and coastal organisations (both government and non-government) with an integrated catchment management focus. This includes 'Friends of' groups, Landcare and Coastcare groups, community organisations, government agencies, Councils and land managers.

BCN offers a variety of services to educational institutions, the wider community, other environmental organisations, businesses and government bodies. We run a number of programs and projects in Geelong and the Bellarine Peninsula including volunteering programs, habitat restoration works and the facilitation of environment focused events and activities.

**Our Vision** is for 'Healthy, flourishing and diverse ecosystems cared for by an aware and engaged community.'

**Our Mission** is 'To be an integrated, inclusive and collaborative network that educates, facilitates, connects and empowers groups and individuals to care for the living things of the land and water of the Bellarine catchment.

## PRESIDENT'S REPORT

## Vicki Perrett



I'm delighted to report another successful year for Bellarine Catchment Network (BCN), delivering extensive community engagement, environmental education, bush regeneration and biodiversity services across the Bellarine and Greater Geelong. BCN remains firmly focused on activating, engaging and empowering people to care for the environment.

Our success reflects the strength of collaboration with our members and partners and our shared commitment to protecting the Bellarine.

#### **Our Network**

Membership continues to grow, reinforcing our collaborative model. As of June 2025, BCN has 45 member organisations: 36 groups and 9 associates. New members include Born Wild Community, Geelong Gardens for Wildlife, Ocean Grove Rotary, St Leonards Community Care and the Marine and Freshwater Discovery Centre.

Members strongly supported the Nature Mentors program, which we hope to continue subject to funding. On behalf of the Committee, I thank all network members for their dedicated conservation work throughout the region.

#### **Our Team and Centre**

Building on a stronger financial position, BCN expanded its team to six (4.4 EFT). We welcomed Brooke McGovern (Community Engagement Officer), Ash Baldwin (Biodiversity Officer) and Diane Heafield (Administration Officer), who have all settled well under the guidance of Matt Crawley (Executive Officer) and Naomi Wells (Coastal and Biodiversity Program Leader). They join Daniel Morrison (Biodiversity Field Officer) and our regular casuals, who deliver quality onground services in often challenging conditions.

Our renovated Bellarine Environment Centre (BEC) has become a valued hub for staff, committee and members. Following an independent valuation, the Centre was added to BCN's fixed assets, strengthening our balance sheet.

#### **Education and Engagement**

BCN again delivered a strong program of community engagement, working with primary and secondary schools to inspire students to protect their local environment.

Over summer, we collaborated with land managers to deliver events for over 1,500 participants, supported by our dedicated network groups. Popular initiatives such as Twilight Walks attracted new audiences, while our Events Calendar website remained a key resource for promoting local environmental activities.

Our incredible volunteers remain at the heart of BCN, dedicating countless hours to bush regeneration and habitat restoration across the Bellarine.

## **Partnerships**

Partnerships remain central to BCN's collaborative model, and we are now working alongside all public land managers on the Bellarine. This year, BCN delivered place-based environmental services for Barwon Water, Barwon Coast, Bellarine Bayside, Bellarine Community Health, Bendigo Bank, Borough of Queenscliffe, City of Greater Geelong, Coastcare Victoria, Corangamite CMA, Geelong Cemeteries Trust and Moremac.

We continued our valued collaboration with Corangamite CMA and Bellarine Landcare Group, especially with their facilitator Sophie Small. BCN also became an approved supplier for both the Borough of Queenscliffe and City of Greater Geelong, positioning us to quote for more environmental contracts. Before taking long service leave, Matt negotiated two exciting multi-year strategic partnerships with Barwon Water and Geelong Cemeteries Trust.

#### Governance

This year, the Committee and Leadership Team strengthened governance and accountability. Two sub-committees were established: 1) Finance Sub-committee – overseeing budgeting and reporting and 2) HR Sub-committee – managing policy, recruitment, compliance, performance and staff wellbeing. We held a combined committee and staff workshop in February, which confirmed we were fulfilling BCN's mission and strategic goals, while identifying opportunities for further growth. The Committee updated Matt's title to Executive Officer to reflect his leadership role. He successfully embraced our desire to expand our fee-for-service stream as this reduces our reliance on grant funding and enhances our resilience.

I extend sincere thanks to my fellow volunteer committee members (featured below) for their dedication and support: Graeme O'Leary (Treasurer), Margot Busch (Secretary), Beth Ross (Vice President), Andrea Dennett, Jon Duthie and Graham Possingham (Finance SC).

#### **Advocacy and Networking**

BCN continues to advocate for First Peoples, climate action, the circular economy, clean energy and nature protection at all levels of government. While the G21 Regional Alliance remains suspended, there is continuing support for two Sustainability Pillar programs: the Clean Economy transition and Nature Positive.

BCN is a professional, resilient and community-driven organisation committed to growing conservation impacts, expanding public reach, building capacity and ensuring financial stability. Together with our members, partners and volunteers, we will continue to protect biodiversity and make Country healthy for future generations.



## TREASURER'S REPORT

BCN recorded a Total trading income of \$561,782, comprising of Fee-for-Service Income (44%), Partnership Income (26%), Local, State Government and other Non-Government Grants (26%) and Auspice Income and sundry income sources such as donations, interest and reimbursements (4%).

BCN ended the financial 2024-25 FY with a loss of \$18.875. This was due primarily to Network Member grants, held in auspice, not being expended by the end of the 2024-25 Financial Year. This resulted in the funds which were recorded as Income in the Profit and Loss Statement being being transferred to the Balance Sheet and held as a liability.

Careful financial management resulted in total operating expenses of \$580,655, of which employment costs represented the majority (76%). A review of fixed assets by the Finance Subcommittee led to a significant increase in value recorded on the 2024–25 balance sheet, totalling \$1,146,485. This included an independent valuation of the Bellarine Environment Centre (land and buildings) by WPB Group, assessed at \$725,000.

As a consequence of the Asset review, depreciation has been applied to all asset categories resulting in a downward adjustment to the FY 2023-24 Total Fixed Assets and Total Asset values. Depreciation has also been included in the P&L statement under operating expenses with a downward adjustment to the FY 2023-24 Profit. Liabilities increased by \$31,076 compared with the previous year, bringing total equity to \$962,307 which includes Retained Earnings of \$595,034 (an increase of \$307,917).

The Independent Auditor's Report confirmed that BCN's financial statements provide a true and fair view of the organisation's position as at 30 June 2025 and comply with Australian Accounting Standards. The committee has approved the audited financial statements.

Throughout the year, the Finance Sub-committee prioritised improving financial reporting and analysis, with greater focus on understanding cash flow variations, income streams, asset cycles and planning for significant future expenses. One outcome was the decision to increase insurance cover to ensure adequate protection of BCN's tangible assets.

The Sub-committee also reviewed leased vehicles and, following cost analysis and professional advice, recommended purchasing two work vehicles due for renewal.

#### Additional actions included:

- Joining Landcare Victoria's donation portal to access tax-deductible donations (DGR status).
- Establishing Terms of Reference for the Finance Sub-committee.
- Recommending the implementation of a Subcontractor Agreement.
- Actively identifying potential new income sources and cost-saving measures.


These improvements strengthen BCN's financial resilience and position us well for continued growth and delivery of our conservation mission.



## **EXECUTIVE OFFICER'S REPORT**

I am delighted to report on the project delivery for the 2024-25 year. Our team prides themselves on quality delivery, technical expertise and a professional service. Working for the environment and through the community is what inspires and motivates us.

Implementing projects across various landscapes, land tenures, with community groups and land managers provides a diversity of experience and deepens our knowledge of the Bellarine. Across our community and education programs the total number of events and activities we deliver continues to grow, with attendance rates also trending upwards. In short, this means more opportunities for the community to connect, learn and enjoy nature.



Under Naomi Wells guidance as the Coastal and Biodiversity Program Leader and supported ably by Brooke McGovern as the Community Engagement Officer and other team members, the Engagement Program continues to grow our presence and connection in environmental education. Consistent feedback from the community shows how valued this service is, the skills they implement and the high regard that the community hold them in. Complimentary to this is our observations through monitoring and evaluation of our bush regeneration sites. From the Bellarine Rail Trail Grassy Woodland, to the Rip View Coastal Moonah Woodland, from the Heathy Woodland of Murrk Ngubitj Yarram Yaluk to the Coastal Saltmarsh of The Point, our team implement bush regeneration techniques that are demonstrating improved habitat and floristic quality benchmarks at these and other sites.

Our Biodiversity and On Ground Works team continue to implement a plethora of projects supporting community groups and land managers. Highlights include the Spiny Rush control program within the Borough of Queenscliffe and for Bellarine Landcare Group controlling this invasive triple threat weed. Another is the Bridal Creeper control program for the Borough of Queenscliffe at the Narrows, Rip View and Bunnywoods. This Weed of National Significance has had a significant impact on biodiversity. This project builds on from the biological control agents and applies a herbicide approach to target the energy rich corms that hide under the surface. Historically, a difficult weed to control we are starting to see a trend decreasing its representation in the EVC's of the Bellarine.

I would like to acknowledge Biodiversity Field Officer Daniel Morrison for his skilled and technical approach to controlling this and many other weeds in often difficult and challenging conditions. Alongside these works are the complimentary revegetation projects led by Biodiversity Officer Ash Baldwin and supported by a number of staff members and casuals.

We had a number of successful planting days this financial year with some highlights including a partnership with Barwon Water at Black Rock revegetating Grassy Woodland species, multiple events for The Point including National Tree Day in Coastal Saltmarsh, and the Queenscliff Cemetery Community Planting Day, partnering with Geelong Cemeteries Trust. Thank you to all the staff who contributed to these successful revegetation days, and the efforts of the wonderful volunteers.

## **EXECUTIVE OFFICER'S REPORT**

We are lucky to partner with and support a number of projects with the Bellarine Landcare Group in collaboration with Landcare Facilitator Sophie Small. Sophie brings skill, dedication, passion and always a smile to her work and the team environment at the Bellarine Environment Centre. I would like to acknowledge all these and the many more attributes she brings to the Bellarine Landcare Group and our team-focused delivery.

Lastly, none of this work is possible without a vibrant and supportive Network and Committee. We are fortunate to have a Committee that supports the team, works with our strengths and improves the areas that require it. A supportive Committee is crucial to the success of BCN and underpins everything we do. We acknowledge and thank them for their time and dedication.




## **OUR TEAM**

## PROGRAM HIGHLIGHT

## Nature Mentors

In 2024, Bellarine Catchment Network successfully received a grant from the City of Greater Geelong to help build the capacity of network groups. This project was named 'Nature Mentors' and aimed to deliver a range of workshops and cultural sessions with a specific focus on topics to engage and recruit volunteers. These workshops including the following:

- Group management (incorporation, insurance, safety, committees)
- · Social media (Facebook, Instagram and BCN's Events Calendar Website)
- Graphic design (Canva and design principles)
- · Weed identification and bush regeneration
- · Indigenous plant identification
- 4 x cultural sessions with Wadawurrung at Curlewis, Ocean Grove, Drysdale and Geelong.

#### Some of the feedback from participants included:

"Bellarine Catchment Networks 'Group Management' workshop was beneficial not only because of the tailored information presented on, but also because of the real-life experiences they were able to share. It gave a realistic and tangible feel to the session - if BCN can do this, other environmental groups can too."

"A lot of great topics were covered in this session and at the end there wasn't a sense that any major focus areas had been missed. It was a perfect balance of enticing people in with Charity status freebies, to safety and policy."

In total, 75 people from network groups and the community attended workshops and sessions in the 2024-25 financial year. Thanks to all the volunteers and group leaders who attended these sessions.

## PROGRAM HIGHLIGHT

## Corporate Days

This financial year, our fantastic team delivered multiple high-profile corporate days to connect some of Geelong's largest businesses with our local environment. At BCN, we see the value of providing these organisations with hands-on opportunities to learn, engage and protect what is in their backyard. Below is a summary of these corporate days.

#### **KPMG**

We worked collaboratively with the City of Greater Geelong to deliver a large-scale corporate day for this Melbourne and Geelong-based company. Over 260 staff joined us at the Geelong Botanic Gardens to learn about the local Flying Foxes and conduct a litter audit of waste they had collected from local Geelong beaches. A huge thanks goes to Brooke McGovern for coordinating an impactful and engaging litter audit session, as well as Ash and Elissa for assisting on the day.

#### **GMHBA**

We facilitated a hands-on corporate day for the Marketing Department of this Geelong-based company at Murrk Ngubitj Yarram Yaluk. Participants enjoyed learning about the regeneration of this site and got their hands dirty removing Cat's Ears.

#### **BARWON WATER**

Thanks to funding from the City of Greater Geelong, we were able to facilitate a corporate day for Barwon Water at Black Rock. Both Barwon Water staff and local community groups were able to revegetate 1500 indigenous plants at this site and also learnt about the unique environmental value through a flora and fauna walk and talk.



## PROGRAM HIGHLIGHT

## Network Support

Each year, Bellarine Catchment Network supports our Network groups in a number of ways. Some of this support is intangible or minimal, but over a whole year our support to the network adds up significantly. This year we developed a processes to capture all of this support, from physical resources borrowed, provision of Letters of Support and providing advice.

BCN staff and committee started recording this support from March 2025 to June 2025 and in total, over 33 hours of staff and committee time was contributed to the following:
